Attached please find the proposed rule draft that was produced by the workgroup in February. It has the date 3-21-2017 in the title. It is attached to this email so that you can compare it to the latest draft of the rule proposal which is dated 4-6-2017.

The primary variation contained in the new proposal is the addition of a two year assessment process. There were other minor changes made to address some of the concerns raised by other agencies.

Please review the latest version of the proposed regulation and reply with your comments no later than close of business Wednesday, April 12. I apologize for the rush, but the next filing date we can possibly make is noon on April 19th. If we can make that, then we can have a public hearing on the rule as early as May 23rd, I believe.
